Putting research into practice for nationwide impact

Research plays a central role in ServeMinnesota's work, informing every stage of program development from design through ongoing evaluation and continuous improvement. Combined with community members' expertise and the people power of AmeriCorps, rigorous research helps ServeMinnesota build programs that have a nationwide impact.

The National Service and Science Collaborative (NSSC) at ServeMinnesota fuels effective AmeriCorps programs. NSSC researchers evaluate the impact of existing programs; partner with researchers and community members to develop new programs; and investigate ways to make AmeriCorps programs even better.

Research has clearly demonstrated the impact of programs like Reading Corps and Math Corps. ProvenTutoring, a coalition of literacy and math programs that deliver results and are endorsed by Johns Hopkins University, invited the programs to join their portfolio. The National Student Support Accelerator at Brown University also endorses Reading Corps enthusiastically. "We were impressed that Reading Corps has replicated randomized controlled trials across time and location," said Dr. Matthew Kraft, associate professor of education and economics at Brown. "Each trial demonstrated that the program has a direct impact on student growth ... with potential to close opportunity gaps for students of color, students from low-income families, and English language learners."

In 2022, thanks in part to the NSSC's work, the nonprofit Results for America recognized Minnesota as one of eight states leading the nation in using evidence and data to accelerate economic mobility, advance equity, and deliver better results for residents.

Reading Corps tutors serve in 78 of Minnesota's 87 counties, and Math Corps is in 62. Fourteen states and the District of Columbia are now home to Reading Corps programs, and Math Corps is implemented in seven states.

True collaboration increases impact

At ServeMinnesota, research means using a systematic process to understand an issue better; putting research into practice means applying those findings to AmeriCorps programs. “Practice is about doing things in the real world, and the real world is where problems — and solutions — are best understood,” said Dr. David Parker, ServeMinnesota’s vice president of research and development. “Researchers provide the tools of science — data, methods, analyses — and practitioners provide the knowledge and lived experiences that make research relevant.”

The 2019 development of K–3 Math Corps, recently evaluated at sites in Minnesota and Georgia, is one example of how the research-to-practice process works, said Dr. Peter Nelson, vice president of impact and innovation. “We reviewed the literature on K–3 math, including intervention as well as best practices guides. We also connected with researchers in the field who focus on early elementary math intervention and talked to site partners and community members,” to develop the model.

Community members have always been crucial partners in helping to improve programs and make sure that they truly meet community needs. Their role in the process is expanding, according to Dr. Sandy Pulles, vice president of equity and inclusion. “Right now, we’re considering how we can proactively engage with the community from the beginning to really design a program that is in alignment with community needs. Our goal is that community members are full members of the research team.”

From tutor to teacher: The Reading Corps and Math Corps pipeline

Minnesota is experiencing a teacher shortage. AmeriCorps service provides a unique learning experience that inspires people to launch a career in education and gives them the skills to be better prepared for the classroom.

As a recent graduate in a corporate job, Keven wasn’t fulfilled. A friend recommended AmeriCorps. That changed his career trajectory completely. “Serving with Reading Corps and Math Corps is a really great introduction to what it’s like to work with kids all day, every day. I found it incredibly rewarding to watch my students’ skills and confidence grow,” Kevin said. “While tutoring, I felt a spark of joy and purpose I hadn’t felt before,” he said. “That was nearly 10 years ago, and that spark ignited my career as a science teacher. Tutoring turned me toward a professional path I wouldn’t have explored otherwise.”

Responding to Minnesota's needs: Refugee Response Initiative

When more than 1,200 people who evacuated from Afghanistan arrived in Minnesota in 2022, the Department of Human Services (DHS) turned to ServeMinnesota to help them begin their new lives.


DHS knew ServeMinnesota was equipped to quickly train and deploy AmeriCorps members as resettlement navigators, connecting families with the resources available through the state's network of federally funded resettlement organizations. Together, Refugee Response Initiative (RRI) was launched.

Forty-four RRI members worked with refugee families and individuals as soon as they arrived in Minnesota, serving as some of the first friendly faces welcoming them to the U.S. and helping them settle into temporary housing. There, the RRI team connected folks with short-term resources, including health care and pro bono legal services, and helped children find some normalcy through safe, supervised play.

As the Afghan families moved into new homes, members visited to help with everything from tech support to job applications to exploring new neighborhoods. Along the way, they built warm relationships with the families — joining them for meals, helping them welcome new babies, and teaching them skills they need to succeed in the U.S.

RRI member Melody, part of the initiative's tech team, worked with a woman who was new to using a computer mouse. "She's super capable, speaks multiple languages and manages so much for her family," Melody said. "She just hadn't used a desktop computer before. She wanted to learn so she could help her kids learn."

The success of RRI inspired the launch of Resettlement Corps in the fall of 2022 — a program in which AmeriCorps members serve for a year helping newcomers from many countries access housing, employment, legal services, education, and other resources. This is one example of how ServeMinnesota adapts to meet state priorities.


