Acceptance of the Terms of Use

These terms of use are entered into by and between you and ServeMinnesota, a Minnesota nonprofit corporation ("**Company**," "**we**," or "**us**"). The following terms and conditions, including any documents incorporated herein (collectively, the "**Terms of Use**"), govern your access to and use of www.serveminnesota.org, including any content, functionality, and services offered on or through www.serveminnesota.org (the "**Website**").
